14 CFR Part 121 - OPERATING REQUIREMENTS: DOMESTIC, FLAG ...

The Federal Aviation Administration (FAA) grants the authority to operate scheduled air service in the form of a Federal Aviation Regulations (FAR) 121 certificate. Air carriers authorized to operate under a Part 121 certificate are generally large, U.S.-based airlines, regional air carriers, and all cargo operators. All Part 121 air carriers are required to have an FAA-approved hazardous materials (aka dangerous goods) program.

The FAA Aviation Safety Organization issued a final rule that was published on January 8, 2015, requiring operators authorized to conduct operations under part 121 to develop and implement a Safety Management System. The rule adds a new part 5 to title 14 of the Code of Federal Regulations (CFR), creating the general framework for an SMS that a part 121 air carrier may adapt to fit the needs of its operation.

Parts 121, 141 and 142 also have Operations Specifications. The Ops Specs are what allows companies to deviate from certain CFRs. For example, a Part 91 pilot has to have an alternate when the weather within one hour of their ETA is less than 2000 feet and 3 miles visibility.

Part 121 of the Civil Aviation Safety Regulations 1998 (CASR) will set the minimum acceptable standards applicable to larger aeroplanes that are conducting air transport operations. Larger aeroplanes in Part 121 of CASR means: with a maximum take-off weight (MTOW) of more than 8,618 kg. with a maximum take-off weight (MTOW) of 8,618 kg or more.
