Medicare claims must be filed no later than 12 months (or 1 full calendar year) after the date when the services were provided. If a claim isn't filed within this time limit, Medicare can't pay its share. For example, if you see your doctor on March 22, 2019, your doctor must file the Medicare claim for that visit no later than March 22, 2020.

### How do I file a claim? | Medicare

Medicare Part A (Hospital Insurance) or Medicare Part B (Medical Insurance) claims: Visit MyMedicare.gov, and log into your account. You'll usually be able to see a claim within 24 hours after Medicare processes it. Check your Medicare Summary Notice (MSN). The MSN is a notice that people with Original Medicare get in the mail every 3 months.
