A History of CLSI's Work on Antimicrobial Susceptibility ...

The NCCLS (now known as the CLSI [Clinical and Laboratory Standards Institute]) defines an antibiogram (ABGM) as an overall profile of antimicrobial susceptibility results of a microbial species to a battery of antimicrobial agents , which should reflect patient care needs along with the institution's formulary . When properly prepared and interpreted, ABGMs are an important resource for healthcare providers.
